2009 Autumn Scholarship Drive Information & Application Packet

The Center for Real Estate Education and Research in partnership with the Ohio Association of Realtors (OAR) offers more than \$20,000 each autumn in scholarships. The total money available for scholarships is divided into several scholarship awards. The amount of each scholarship award varies each year and is based on the total money available, the amount of applications received and the number of qualified applicants. Typically there are ten to fifteen scholarships given out with awards ranging from \$1,000 to \$4,000. Each applicant can only earn one scholarship. By submitting one application the applicant is eligible to receive each available scholarship.

Determining the scholarship award winners is done by a two step process. In the first step, the applicant pool is narrowed down to approximately fifteen candidates. This is based on essay responses, GPA, demonstration of an intent of a career in real estate and other smaller factors. In the second step, those fifteen candidates will receive a short interview by a group of OAR members who will then decide the scholarship recipients and the amount of each award.

The deadline for submission to be considered for these scholarships is 5pm, October 23rd, 2009. Completed scholarship submissions should be emailed to realestate@osu.edu.

All currently enrolled students in the Fisher College of Business, both graduate and undergraduate, full and part-time, are eligible.
